Rating System for Lead

<u>Color</u>	<u>Rating</u>	<u>Lead level</u>	<u>Notes</u>
Red	Highly Contaminated	600ppm or above	The CPSC standard for lead in paint is 600ppm.
Black	Contaminated	Up to 600ppm.	19 states, including MA, have laws restricting lead in packaging at 100ppm.

Rating System for PVC / Chlorine

Chlorine | PVC?

>10,000 p | The material is most likely PVC given the high level of chlorine in the product.
<10,000 p | The material is unlikely to be PVC.
